**ORDINANCE NO. 16-77**

**AN ORDINANCE AMENDING THE 2017 SALARY ORDINANCE, COMMON COUNCIL ORDINANCE NO. 16-50, TO ADD POSITION OF PART TIME PROGRAM INSTRUCTOR IN PARKS AND RECREATION DEPARTMENT**

WHEREAS, the Greenwood Common Council passed Ordinance 16-50 (the “2017 Salary Ordinance”) setting 2017 salaries for all employees and stating whether each position is exempt or non-exempt;

WHEREAS, the Parks and Recreation Director is requesting to add the position of part time Program Instructor at an hourly wage of \$40/hr.;

WHEREAS, the change will be presented to the Park Board for ratification and approval at its February meeting; and

WHEREAS, no additional appropriation by Council is necessary to fund this change.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, AS FOLLOWS:

Section 1. The 2017 Salary Ordinance, Common Council Ordinance No. 16-50, Section 3, is hereby amended, to add a new part time position of:

**Parks and Recreation Department**

- Program Instructor (NE) \$40.00/hr.

Section 2. This Ordinance shall have no effect upon any other provisions of Ordinances No. 16-50 except as herein provided, and all other sections of Ordinance No. 16-50 not inconsistent herewith shall remain the same.

Section 3. The sections, paragraphs, sentences, clauses, phrases and words of this Ordinance are separable, and if any word, phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional, invalid or unenforceable by the valid judgment or decree of a Court of competent jurisdiction, such unconstitutionality, invalidity or unenforceability shall not affect any of the remaining words, phrases, clauses, sentences, paragraphs and sections of this Ordinance.

Section 4. This Ordinance shall be in full force from and after its passage, approval and publication according to law.
