

**GREENWOOD COMMON COUNCIL**

**ORDINANCE NO. 15-87**

**AN ORDINANCE AMENDING THE 2016 SALARY ORDINANCE, COMMON COUNCIL ORDINANCE NO. 15-48, TO CORRECT SALARY OF PART-TIME RECORDS CLERK AND JOB TITLE OF ADMINISTRATIVE ASSISTANT**

WHEREAS, the Greenwood Common Council passed Ordinance 15-48 (the "2016 Salary Ordinance") setting 2016 salaries for all employees and stating whether each position is exempt or non-exempt;

WHEREAS, due to an error, the 2016 Salary Ordinance incorrectly listed the part-time hourly rate for the Records Clerk in the Clerk's Office and incorrectly stated the title of the full time employee in the Clerk's Office;

WHEREAS, the Clerk has reviewed and approved this recommendation; and

WHEREAS, no additional appropriation by Council is necessary to fund this change.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, AS FOLLOWS:

Section 1. The 2016 Salary Ordinance, Common Council Ordinance No. 15-45, is hereby amended to increase the part time hourly rate for the Part Time Records Clerk from \$12.24/hr. to \$15.00/hr.

Section 2. The 2016 Salary Ordinance, Common Council Ordinance No. 15-45, is hereby amended to change the title of the full time employee in the Clerk's Office from Administrative/Assistant/Transcriptionist to Administrative Assistant.

Section 3. This Ordinance shall have no effect upon any other provisions of Ordinances No. 15-48 except as herein provided, and all other sections of Ordinance No. 15-48 not inconsistent herewith shall remain the same.

Section 4. The sections, paragraphs, sentences, clauses, phrases and words of this Ordinance are separable, and if any word, phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional, invalid or unenforceable by the valid judgment or decree of a Court of competent jurisdiction, such unconstitutionality, invalidity or unenforceability shall not affect any of the remaining words, phrases, clauses, sentences, paragraphs and sections of this Ordinance.

Section 5. This Ordinance shall be in full force from and after its passage, approval and publication according to law.


