RESOLUTION NO. 17-05

A RESOLUTION APPROVING REDEVELOPMENT COMMISSION RESOLUTION NO. 2017-05 AMENDING THE ECONOMIC DEVELOPMENT PLAN FOR THE GREENWOOD EASTSIDE ECONOMIC DEVELOPMENT PLAN AND APPROVING THE ORDER OF THE GREENWOOD ADVISORY PLAN COMMISSION

WHEREAS, the City of Greenwood ("City") Redevelopment Commission ("RDC"), governing body of the City of Greenwood Department of Redevelopment (the "Department"), on February 27, 1997, adopted its Resolution 97-1 (as subsequently confirmed and amended, the "Declaratory Resolution") establishing an economic development area known as the "Greenwood Eastside Economic Development Area" (the "Area"), and approving an economic development plan for the Area (as subsequently amended, the "Plan") pursuant to Ind. Code § 36-7-14 as amended (the "Act");

WHEREAS, the Declaratory Resolution approved the Plan, which contained specific recommendations for economic development in the Area;

WHEREAS, on February 14, 2017, the RDC adopted Resolution No. 2017-05 ("Amendment"), attached hereto as Exhibit A, amending the Plan by addition of a Plan Supplement to expand the Plan's project objectives;

WHEREAS, the Act requires approval of the Amendment by the Greenwood Advisory Plan Commission ("Plan Commission"), which occurred on March 13, 2017, which approving order is attached hereto as Exhibit B; and

WHEREAS, the Act requires the Common Council of the City to approve the Amendment and the action of the Plan Commission;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, THAT:

Section 1. Subject to an amendment deleting the North City Center Parking Lot Redevelopment and Repurposing Project from the Plan Supplement, the action of the Redevelopment Commission on February 14, 2017, adopting the Amendment is in all respects approved, ratified and confirmed by the Common Council.

Section 2. Subject to an amendment deleting the North City Center Parking Lot Redevelopment and Repurposing Project from the Plan Supplement, the action of the Plan Commission on March 13, 2017, approving the Plan Amendment is in all respects approved, ratified and confirmed by the Common Council.

Section 3. This Resolution shall be effective from and after its passage and approval by the Mayor.
