ORDINANCE NO. 17-23

AN ORDINANCE PROVIDING FOR AN ADDITIONAL APPROPRIATION FROM THE AVIATION FUND TO BUDGET CLASSIFICATION 445 IN THE AVIATION BUDGET FOR EQUIPMENT PURCHASE (\$31,280)

WHEREAS, the Airport Manager would like to purchase a refurbished aircraft tug with increased capabilities;

WHEREAS, the Aviation Fund currently has a reserve fund of 34% of its revised budget and will continue to maintain a 31.2% reserve fund after the proposed appropriation;

WHEREAS, the Interim Controller has found that the Aviation Fund has a sufficient balance to fund this additional appropriation; and

WHEREAS, the Common Council has determined that it is necessary and appropriate to make the requested additional appropriation and shall hold a public hearing in accordance with law.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, THAT:

<u>Section 1</u>. For the expenses of the City of Greenwood, the following additional sum of money is hereby appropriated and ordered set apart out of the fund herein named and for the purposes herein specified subject to the laws governing the same:

AVIATION FUND Amount

445 Machinery and Equipment

\$31,280

Said sum is to be used for expenditures of the type and kind permitted by law.

<u>Section 2</u>. This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
