

**GREENWOOD COMMON COUNCIL**

**ORDINANCE NO. 17-27**

**AN ORDINANCE PROVIDING FOR AN ADDITIONAL APPROPRIATION FROM THE FIRE OPERATING FUND TO BUDGET CLASSIFICATION 338 IN THE FIRE DEPARTMENT BUDGET (\$107,067)**

WHEREAS, it is necessary to appropriate an additional One Hundred Seven Thousand Sixty-Seven and no/100 Dollars (\$107,067.00) from the Fire Fund to the Fire Department Budget to cover debt service payments relating to equipment lease purchases;

WHEREAS, the funding was not originally included in the 2017 budget because the Department was considering paying off the balances of the leases early, however, it is has chosen not to do so;

WHEREAS, the Controller has found that the Fire Fund has a sufficient balance to fund this additional appropriation and that the Fire Fund will have a sufficient year end reserve ratio of 39% following the appropriation; and

WHEREAS, the Common Council has determined that it is necessary and appropriate to make the requested additional appropriation and shall hold a public hearing in accordance with law.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, THAT:

Section 1. For the expenses of the City of Greenwood, the following additional sum of money is hereby appropriated and ordered set apart out of the fund herein named and for the purposes herein specified subject to the laws governing the same:

<u>FIRE FUND</u>	<u>Amount</u>
338 Debt Service	\$107,067

Said sum is to be used for expenditures of the type and kind permitted by law.

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
