### **ORDINANCE NO. 17-36**

# AN ORDINANCE TRANSFERRING FUNDS WITHIN THE CUMULATIVE CAPITAL IMPROVEMENT FUND FROM BUDGET CATEGORY 442 TO BUDGET CATEGORY 331

WHEREAS, funds may be transferred within a fund from one budget series to another budget series by ordinance of the fiscal body at a public meeting without advertising a public hearing if no additional appropriations are required;

WHEREAS, the Controller needs to transfer certain fees within the Cumulative Capital Improvement Fund from Budget Category 442 to Budget Category 331 to correct the classification for inspection fees in the amount of \$22,000; and

WHEREAS, no additional appropriation is necessary to accommodate these changes.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, THAT:

<u>Section 1</u>: For the expenses of the City of Greenwood, and its institutions for the fiscal year ending December 31, 2017, the City of Greenwood hereby determines the transfer of the following sums of money to be necessary and the following sums are hereby transferred and ordered set apart out of the fund herein named subject to the laws governing the same:
