**A RESOLUTION OF THE GREENWOOD COMMON COUNCIL EXPRESSING  
INTEREST IN THE PURCHASE OF CERTAIN REAL PROPERTY AT 1795 NORTH 75  
EAST**

WHEREAS, the Parks and Recreation Department is interested in purchasing certain real estate for parks and recreation purposes;

WHEREAS, pursuant to Ind. Code § 36-1-10.5, before a purchase of real property costing greater than Twenty-Five Thousand and no/100 Dollars (\$25,000.00) can occur, the Common Council must first pass a resolution stating it is interested in making a purchase of the specified land or a structure;

NOW, THEREFORE, BE IT RESOLVED BY THE GREENWOOD COMMON COUNCIL AS FOLLOWS:

Section 1. The Common Council, pursuant to Ind. Code § 36-1-10.5, hereby expresses its interest in purchasing the real property located at 1795 North 75 East (Parcel Nos. 41-05-09-011-002.000-050 and 41-05-09-011-001.000-050) in Greenwood, Indiana for use by the Parks and Recreation Department.

Section 2. This Resolution shall be in full force and effect after its passage and approval by the Mayor of the City of Greenwood.


