

**GREENWOOD COMMON COUNCIL**

**ORDINANCE NO. 17-51**

**AN ORDINANCE TRANSFERRING FUNDS WITHIN THE AVIATION FUND FROM  
BUDGET CATEGORY 222 TO BUDGET CATEGORY 335**

WHEREAS, funds may be transferred within a fund from one budget series to another budget series by ordinance of the fiscal body at a public meeting without advertising a public hearing if no additional appropriations are required;

WHEREAS, the Airport needs to pay a sewer availability fee and sewer connection fee which requires transferring funds from Budget Category 222 (Operating Supplies) to Budget Category 335 (Utilities); and

WHEREAS, no additional appropriation is necessary to accommodate these changes.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, THAT:

Section 1: For the expenses of the City of Greenwood, and its institutions for the fiscal year ending December 31, 2017, the City of Greenwood hereby determines the transfer of the following sums of money to be necessary and the following sums are hereby transferred and ordered set apart out of the fund herein named subject to the laws governing the same:

Utilities (335)	\$29,076.00

Section 2. It has been shown that a certain existing Fund now has unobligated balances which will not be used or encumbered, it is further ordained that the following Fund be reduced by the following amounts and said amounts be transferred subject to the laws governing the same:

<u>AVIATION FUND</u>	
Operating Supplies (222)	\$29,076.00

Section 3. This transfer does not necessitate expenditure of more money than was set out in the published budget for the year 2017, there is no necessity of advertising said transfer, and it may be done in any regular public meeting without notice, and without approval of the Department of Local Government Finance.

Section 4. This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
