**ORDINANCE NO. 17-46**

**AN ORDINANCE FOR APPROPRIATIONS AND TAX RATES FOR THE 2018  
BUDGET YEAR**

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA:

That for the expenses of the City government and its institutions for the year ending December 31, 2018, the sums of money shown on attached Budget Form 4A are hereby appropriated and ordered set apart out of the several funds herein named and for the purposes herein specified, subject to the laws governing the same.

Such sums herein appropriated shall be held to include all expenditures authorized to be made during the year, unless otherwise expressly stipulated and provided by law.

In addition, for purposes of raising revenue to meet the necessary expenses of the city government, tax rates are shown on attached Budget Form 4-B and included herein.

Two (2) copies of Budget Form 4-A and 4-B for all funds and departments are made a part of the budget report and submitted herewith.
