ORDINANCE NO. 17-56

AN ORDINANCE AMENDING THE 2017 SALARY ORDINANCE, COMMON COUNCIL ORDINANCE NO. 16-50, TO AMEND THE SALARY FOR CRIMINAL ANALYST IN THE POLICE DEPARTMENT

WHEREAS, the Greenwood Common Council passed Ordinance 16-50 (the “2017 Salary Ordinance”) setting 2017 salaries for all employees and stating whether each position is exempt or non-exempt;

WHEREAS, the Police Chief is requesting to amend the salary ordinance to match the amount approved in the 2017 Budget, Ordinance 16-49;

WHEREAS, no additional appropriation by Council is necessary to fund this change.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, AS FOLLOWS:

Section 1. The 2017 Salary Ordinance, Common Council Ordinance No. 16-50, Section 3, is hereby amended, to add a new part time position of:

Police (all salaries to be paid from GF)

- Criminal Analyst (1) (NE) \$42,500 (*\$1,634.61*)

Section 2. This Ordinance shall have no effect upon any other provisions of Ordinances No. 16-50 except as herein provided, and all other sections of Ordinance No. 16-50 not inconsistent herewith shall remain the same.

Section 3. The sections, paragraphs, sentences, clauses, phrases and words of this Ordinance are separable, and if any word, phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional, invalid or unenforceable by the valid judgment or decree of a Court of competent jurisdiction, such unconstitutionality, invalidity or unenforceability shall not affect any of the remaining words, phrases, clauses, sentences, paragraphs and sections of this Ordinance.

Section 4. This Ordinance shall be in full force retroactive to January 1, 2017 after its passage, approval and publication according to law.
