ORDINANCE NO. 17-58

**AN ORDINANCE AMENDING CHAPTER 2, ARTICLE 6, SECTION 2-38 OF THE
GREENWOOD MUNICIPAL CODE (1993) DESIGNATING NO PARKING ON
CERTAIN SIDES OF THE STREETS IN SUMMERFIELD VILLAGE**

WHEREAS, the City of Greenwood has the authority to adopt ordinances regulating parking on the streets and public rights-of-way within its jurisdiction pursuant to Ind. Code §§ 9-21-1-2 and 3;

WHEREAS, a request has been submitted to the Greenwood Common Council that parking be prohibited on the certain sides of the streets in Summerfield Village; and

WHEREAS, the Common Council has conducted an investigation and determined that prohibiting such parking is in the best interests of citizens;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, THAT:

Section 1. The Greenwood Municipal Code, Chapter 2, City Administration, Article 6, Ordinance Violations Bureau, Sec. 2-38, Schedule of Ordinances and Civil Penalties, as amended, is hereby amended to designate “No Parking” on the:

- The east side of Harvest Moon Drive;
- The west side of Providence Court;
- The west side of Providence Drive south of Winterwood Drive;
- The north side of Winterwood Drive;
- The west side of Summerwood Lane;
- The south side of Declaration Drive;
- The west side of Summer Breeze Way;
- The north and east side of Frostwood Lane; and
- The north side of Snowflake Circle.

within the City of Greenwood and to place the same within the schedule of ordinances and code provisions listed within the Ordinance Violations Bureau with the stated specific civil penalty of Fifteen Dollars (\$15.00) (for the first violation within a calendar year), and which amendment reads as follows:

- (a) The Greenwood Common Council hereby designates no parking within the City of Greenwood limits on, Civil Penalty - \$15.00, on:
 1. The east side of Harvest Moon Drive;
 2. The west side of Providence Court;
 3. The west side of Providence Drive south of Winterwood Drive;
 4. The north side of Winterwood Drive;
 5. The west side of Summerwood Lane;
 6. The south side of Declaration Drive;
 7. The west side of Summer Breeze Way;
 8. The north and east side of Frostwood Lane; and
 9. The north side of Snowflake Circle.
- (b) The Greenwood Common Council hereby directs the marking by signs or otherwise of the parking restriction in the appropriate locations in accordance with subsection (a) above and in accordance with the Indiana Manual on Uniform Traffic Control Devices.

Section 2. This Ordinance does not affect any other sections of the Greenwood Municipal Code, as amended, or other ordinances except as herein provided and all other sections of the Code and other ordinances shall remain the same.

Section 3. The sections, paragraphs, sentences, clauses, phrases and words of this Ordinance are separable, and if any word, phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional, invalid or unenforceable by the valid judgment or decree of a Court of competent jurisdiction, such unconstitutionality, invalidity or unenforceability shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Ordinance.

Section 4. This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
