ORDINANCE NO. 17-55

**AN ORDINANCE PROVIDING FOR AN ADDITIONAL APPROPRIATION FROM
THE PARKS FUND OPERATING BALANCE TO BUDGET CLASSIFICATION 111 IN
THE PARKS DEPARTMENT BUDGET (\$95,000)**

WHEREAS, the Parks Director is requesting an additional Ninety-Five Thousand and no/100 Dollars (\$95,000.00) from the Parks Fund to the Parks Department Budget to provide funding for payroll through the remainder of the year due to busy seasons at the newly renovated Community Center, seasonal winter maintenance staff, and Freedom Springs Aquatic Center;

WHEREAS, the Parks Department has a strong reserve ratio and cash balance and can support the appropriation;

WHEREAS, the Finance Department has found that the Parks Fund has a sufficient balance to fund this additional appropriation;

WHEREAS, the Common Council has determined that it is necessary and appropriate to make the requested additional appropriation and shall hold a public hearing in accordance with law.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, THAT:

Section 1. For the expenses of the City of Greenwood, the following additional sum of money is hereby appropriated and ordered set apart out of the fund herein named and for the purposes herein specified subject to the laws governing the same:

<u>PARKS FUND</u>	<u>Amount</u>
111 Salaries and Wages	\$95,000

Said sum is to be used for expenditures of the type and kind permitted by law.

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
