### **GREENWOOD COMMON COUNCIL**

#### ORDINANCE NO. 17-59

## AN ORDINANCE TO AMEND THE TEXT OF CHAPTER 8, TRAFFIC AND PARKING REGULATIONS, ARTICLE 5, SECTION 8-46 RELATED TO SPEEDING IN A DESIGNATED SCHOOL ZONE

WHEREAS, Ind. Code § 9-21-5-2 sets the default maximum speed limit for urban districts as thirty (30) miles per hour;

WHEREAS, Ind. Code § 9-21-5-6 provides that a local authority may alter the speed limit from thirty (30) miles per hour under certain prescribed conditions;

WHEREAS, Ind. Code § 9-21-5-6 provides that a local authority may set speeds for a school district under certain prescribed conditions;

WHEREAS, the City of Greenwood has set speed limits within its municipal boundaries and provided for local enforcement and jurisdiction over such ordinance violations;

WHEREAS, the City desires to amend the times for which its school zone speeding zones are in effect; and

WHEREAS, an amendment to the Greenwood Municipal Code is necessary to enact such prohibitions.

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, THAT:

Section 1. Greenwood Municipal Code (1993), Chapter 8, Article 5, Section 8-47, subsection (a) is hereby amended by replacing "5:00 p.m." with "4:00 p.m."

<u>Section 2</u>. All prior ordinances or parts thereof inconsistent with any provision of this ordinance are hereby repealed to the extent incompatible. This Ordinance shall have no effect upon any other sections of the Greenwood Municipal Code (1993) except as herein provided.

Section 3. The sections, paragraphs, sentences, clauses, phrases and words of this Ordinance are separable, and if any word, phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional, invalid or unenforceable by the valid judgment or decree of a Court of competent jurisdiction, such unconstitutionality, invalidity or unenforceability shall not affect any of the remaining words, phrases, clauses, sentences, paragraphs and sections of this Ordinance.

<u>Section 4</u>. This ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
