ORDINANCE NO. 17-64

AN ORDINANCE PROVIDING FOR AN ADDITIONAL APPROPRIATION FROM <u>THE PARKS FUND TO BUDGET CLASSIFICATION 444 IN THE PARKS</u> <u>DEPARTMENT BUDGET (\$160,000)</u>

WHEREAS, the Director of Parks and Recreation is requesting an additional One Hundred Sixty Thousand and no/100 Dollars (\$160,000.00) from the Parks Fund to the Parks and Recreation Department Budget to construct and additional 65 parking spaces at Freedom Springs;

WHEREAS, the Parks Fund has a strong reserve ratio and cash balance and can support the appropriation;

WHEREAS, the Controller has found that the Parks Fund has a sufficient balance to fund this additional appropriation; and

WHEREAS, the Common Council has determined that it is necessary and appropriate to make the requested additional appropriation and shall hold a public hearing in accordance with law.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, THAT:

<u>Section 1</u>. For the expenses of the City of Greenwood, the following additional sum of money is hereby appropriated and ordered set apart out of the fund herein named and for the purposes herein specified subject to the laws governing the same:

PARKS FUND

DEPARTMENT OF PARKS AND RECREATION Improvements Other than Buildings (444)

\$160,000

Amount

Said sum is to be used for expenditures of the type and kind permitted by law.

<u>Section 2</u>. This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
