RESOLUTION NO. 15-01

**A RESOLUTION OF THE GREENWOOD COMMON COUNCIL EXPRESSING
INTEREST IN THE PURCHASE OF CERTAIN REAL PROPERTY (NOWACKI
PARCEL ALONG U.S. 31)**

WHEREAS, the Department of Parks and Recreation is interested in purchasing a parcel of land for future use in its trail system;

WHEREAS, pursuant to Ind. Code 36-10-3-11, the Parks Board has statutory authority to act as the purchasing agent to purchase real property needed by the Parks and Recreation Department for park use;

WHEREAS, pursuant to Ind. Code § 36-1-10.5, before the Board can make a purchase of real property costing greater than Twenty-Five Thousand and no/100 Dollars (\$25,000.00), the Common Council must first pass a resolution stating it is interested in making a purchase of the specified land or a structure;


NOW, THEREFORE, BE IT RESOLVED BY THE GREENWOOD COMMON COUNCIL AS FOLLOWS:

Section 1. The Common Council, pursuant to Ind. Code § 36-1-10.5, hereby expresses its interest in purchasing approximately 1.75 acres of real property commonly known as the Nowacki parcel located at 440 U.S. Highway 31 (Parcel No. 41-02-32-034-008.001-026) as more specifically depicted in the attached Exhibit A for use by the Parks and Recreation Department.

Section 2. This Resolution shall be in full force and effect after its passage and approval by the Mayor of the City of Greenwood.
