RESOLUTION NO. 25-10

A RESOLUTION OF THE BOARD OF PUBLIC WORKS AND SAFETY OF THE CITY OF GREENWOOD APPROVING EXCHANGE OF PROPERTY WITH THE CITY OF FRANKLIN PURSUANT TO IND. CODE § 5-22-22-10

WHEREAS, the City of Greenwood Board of Public Works and Safety ("Board") has the authority to exchange City of Greenwood ("City") personal property with another governmental body pursuant to Ind. Code § 5-22-22-10;

WHEREAS, the City of Franklin recently had a change in personnel within the police department such that a Level II Point Blank Ballistic Vest Model: HL6M00B70M is no longer needed and is now surplus property;

WHEREAS, the City of Franklin is desirous of disposing of the vest in "as is" condition to the City in accordance with Ind. Code § 5-22-22-10;

WHEREAS, the City is desirous of receiving the vest being offered by the City of Franklin for use in providing services in the police department and is willing to compensate the City of Franklin for the property;

WHEREAS, Ind. Code § 5-22-22-10 allows for the exchange of personal property between governmental bodies as agreed upon by the entities as evidenced by the adoption of a substantially identical resolution by each entity;

WHEREAS, the Board agrees to accept transfer of the vest from the City of Franklin in exchange for payment of the sum of Three Hundred Fifty and No/100 Dollars (\$350.00);

WHEREAS, the vest shall be the City's sole and exclusive property upon adoption and acceptance of the substantially identical Resolutions;


WHEREAS, the Board and the City of Franklin have determined that it would be in their mutual best interests to exchange property pursuant to Ind. Code § 5-22-22-10;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF PUBLIC WORKS AND SAFETY OF GREENWOOD, INDIANA THAT:


