

**GREENWOOD COMMON COUNCIL**

**ORDINANCE NO. 25-16**

**AN ORDINANCE PROVIDING FOR AN ADDITIONAL APPROPRIATION FROM  
THE GENERAL FUND TO BUDGET CLASSIFICATION 431 (\$4,500.00) IN THE  
POLICE MERIT COMMISSION BUDGET**

WHEREAS, the Police Chief requests an additional appropriation from the General Fund in the amount of Four Thousand Five Hundred and no/100 Dollars (\$4,500.00) to Police Merit Commission Budget Classification Professional Services 431, to cover the costs of the public safety test vendor for the Police Department's current hiring process and the Police Merit Commission attorney's fees for the remainder of the year;

WHEREAS, the Controller has determined that the General Fund has a sufficient balance available to fund this additional appropriation;

WHEREAS, the Common Council has determined that it is necessary and appropriate to make the appropriation and shall hold a public hearing in accordance with law,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, THAT:

Section 1. For the expenses of the City of Greenwood, the following sum of money is hereby appropriated and ordered set apart out of the fund herein named and for the purposes herein specified subject to the laws governing the same:


