#### C. Second Reading

ORDINANCE NO. 25-26 AN ORDINANCE TO ESTABLISH A DESIGNATED OUTDOOR REFRESHMENT AREA IN THE CITY OF GREENWOOD, INDIANA (Sponsored by Hill)

Mr. Campbell, I sent you all an email today, I'd just like to read that and share why I am voting no, on Ord. No. 25-26 (DORA). While I appreciate the intent to create a Designated Outdoor Refreshment Area, I believe the concept poses more risk then benefits for our community. My concerns include:

\*Increased enforcement demands on police and public safety personnel.

<sup>\*</sup>Greater risk of public intoxication, nuisance behaviors, and violations of DORA boundaries.

<sup>\*</sup>Potential negative impact on non-alcohol-related business and family-oriented environments.

- \*Added administrative and financial burdens for signage, enforcement and clean up.
- \*Possible conflicts with nearby residential areas, churches, and schools.
- \*Liability and compliance challenges under state alcohol laws.

Enforcement would, in practice, rely on those who directly profit from alcohol sales. For example, there is no practical way to verify how much alcohol is poured into each cup. I can see a "holey-Pokey" moment as a patron approached the boundary-one foot in, one foot out and shake it all about! Meanwhile, all cost for signage, cleanup, and enforcement would fall on the city (which as we've learned is facing extreme fiscal restraints), even though the city receives no direct revenue from the DORA. At minimum, those costs should be borne by the participating businesses that benefit from the program. I also believe the proposed hours for the DORA are excessive. I have attached a list of other cities' DORA hours for comparison. My recommendations are as follows:

- \*Shorten the permitted hours of operation similar to Carmel or Evansville
- \*Establish and application fee or require participating businesses to cover signage, cleanup, and public education cost
- \*Consider implementing a short-term pilot program lasting a few weeks or months
- \*If not a pilot, include a sunset clause and clear evaluation metrics to reassess the program after one year.

Ultimately, DORA expands and activity normally restricted to "21 and over" establishments into public spaces accessible to all ages. I do not believe this is in the best interest of our family-friendly community. I appreciate your consideration. <u>Link to email</u>

Mr. Lekse, I guess I view it as a pilot program already. If there are problems, we can adjust the program or remove it entirely.

Mr. Moan, I would say in light of these comments, at 12 pm to 12 am, 7 day a week policy does in my opinion seem excessive, to allow for that. I'm spent some time looking at other communities that have this, it seems like they limit the hours during weekdays, and reopening back up in the summer months. I think a carte blanche 12 noon to midnight may lead itself to some noise issues. I think the idea of this kind of community environment is pretty good, but I do think that there could itself come to some additional issues.

Mr. Hopper, Rob are you in charge of this?

Mr. Taggart, yeah.

Mr. Hopper, so, the noon to midnight does that encompass like WAMM Fest, Freedom Fest? Does it catch those hours? Is that why?

Mr. Taggart, yeah.

Mr. Campbell, those would be on weekends, wouldn't it? Mr. Taggert, yes.

Mr. Campbell, so restricting hours during weekdays is not affected.

Mr. Moan, so the festivals then would require a special permitting, it that right? Or are those special events included in this ordinance? Are the events required to get a special permit? Mr. Taggart, you'd still have to get the permit for the sale of alcohol for the events.

Mr. Hopper, a question I have, I told somebody I'd ask at Our Lady of Greenwood, it could be a temporary vender for Freedom or WAMM Fest, that way folks can buy their beer at Our Lady and walk-through Craig Park wherever they need to go. Right?

Mr. Taggert, yes.

Mr. Hopper, that's what they wanted, so I just wanted to make sure.

Mr. Moan, I would like to propose an amendment to the week day hours of this ordinance, now is the appropriate time.

Mr. Hopper, Monday through Thursday or Friday? See you are also getting into St. Patrick's Day which could be a day throughout the week.

Mr. Hodson, it could always be amended.

ORDINANCE NO. 25-29 AN ORDINANCE PROVIDING FOR ADDITIONAL APPROPRIATIONS FROM THE FIRE FUND TO BUDGET CLASSIFICATIONS 423 (\$20,333) AND 436 (\$18,601) FOR REPAIRS AND MAINTENANCE (Sponsored by Moan) *Public Hearing scheduled for November 17, 2025* 

Chief Washel, good evening council, this year we've had significant equipment repair costs incurred while we've done a good job of doing what we can to lessen our blow. We're in a position new that we're going to need a little extra funding. We had significant repairs equipment such as a new engine, new transmission for our ladder truck, amongst other things. So, with just those two, we're talking about \$120,000 of unexpected costs and repairs. Thank you.

RESOLUTION NO. 25-20 A RESOLUTION OF THE GREENWOOD COMMON COUNCIL AUTHORIZING THE FILING, ACCEPTANCE AND IMPLEMENTATION OF BROWNFIELD ASSESSMENT GRANT WITH THE U.S. ENVIRONMENTAL PROTECTION AGENCY (Sponsored by Campbell)

Mr. Nelson, the city was notified by the EPA that we're approved to receive a half a million in grant funds. This grant does not require a match from the city of Greenwood. This is a Brownfield Assessment Grant we applied for in 2024.

With this, I would request that if you are in favor that we'd suspend the rules to expedite the resolution so that we can begin working on the grant and the RFP. It is a four-year grant and it is from October 1, 2025 to September 30, 2029. It's now November, so we've missed that first month. I'd appreciate it if we could suspend multiple meetings.

Mr. Moan, can you tell us what the grant is going to be used for?

Mr. Nelson, yes, I can. We will have to work with private land owners as well, but this is an assessment grant. It's doing a lot of environmental planning work. It's not going to be construction work that we're doing. With this grant we'll be able to do phases. Phase one we have the potential for eight environmental site assessments and ten in phase two environmental assessments. Developers come in when this work is done with something that can kickstart.

A "brownfield", which is basically a piece of property that may or may not have potential presence of hazardous substances. So, a lot of this research would be required so this way the city can come in and start to prepare these sites.

Mr. Moan, so helps mitigate environmental hazards on potential sites. This way the city can partner with projects. Am I understanding this correctly?

Mr. Nelson, that would be correct. We do remediation work plans. There could be visioning sessions on how to reuse a piece of property that sat vacant. There would be market studies done for some of these sites. It would include public outreach, and profiles for these properties. So, a lot of this is things that are barriers for redeveloping or reinvestments. So, you typically see a pretty good return for your dollar.
