RESOLUTION NO. 16-08

A RESOLUTION OF THE BOARD OF AVIATION COMMISSIONERS OF THE CITY OF GREENWOOD TO AMEND THE RULES AND REGULATIONS REGARDING SAFETY

WHEREAS, the Board of Aviation Commissioners of the City of Greenwood, Indiana (the "Board") has certain prescribed powers with respect to the operation and management of the Greenwood Municipal Airport as outlined in Ind. Code § 8-22-2-5;

WHEREAS, in accordance with its powers, by Resolution 14-03, the Board adopted the Rules and Regulations;

WHEREAS, the Rules of Regulations, among other things, prescribe certain security requirements regulated by Airport Management;

WHEREAS, since the adoption of Resolution 14-03, safety concerns and experience have indicated the need to update the Rules and Regulations regarding safety;

WHEREAS, the Board has determined it is in the Airport's best interest to amend the Rules and Regulations,

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF AVIATION COMMISSIONERS OF THE CITY OF GREENWOOD, INDIANA THAT:

Section 1. Section 4.1 Security Requirements Regulated by Airport Management is amended to add a subsection 4.1.5 to read as follows:

"If the airport manager determines that any individual poses a safety risk to the airport, aircraft, airport users, or tenants, or engages in threatening and/or disorderly conduct, upon approval by the Board of Aviation Commissioners, such person may be banned from future entry upon airport premises. Corporation Counsel shall provide written notice to the individual of the scope and length of the ban and inform the individual that said ban may be appealed by filing a written notice of appeal with the Board of Aviation Commissioners within ten (10) days of receipt of the notice. If an appeal is filed, the Board of Aviation Commissioners, shall consider that matter as it deems appropriate in its discretion and make a final determination regarding the ban. Once notice is received, the appeal period expired and/or a final determination made by the Board of Aviation Commissioners, if an individual re-enters the airport premises during the length of the ban, he or she shall be subject to referral, upon recommendation of the Chief of Police, to the Johnson County Prosecutor's Office for charges of criminal trespass pursuant to Ind. Code § 35-43-2-2(a)(1) as may be amended."

Section 2. This Resolution does not affect any other provisions of Board of Aviation Commissioners Resolution 14-03, except as provided herein and all other provisions of Board of Aviation Commissioners Resolution No. 14-03 and any previous amendments shall remain the same.

Section 3. The Rules and Regulations as amended herein shall be posted at the Airport Terminal and shall be made accessible online to the public.


Section 4. This resolution shall be in full force and effect on immediately upon its adoption.
