ORDINANCE NO. 17-37

AN ORDINANCE AMENDING GREENWOOD MUNICIPAL CODE SECTION 4-16 TO ADD POLICE LOCKER RENTAL FEE AND AMENDING SECTION 2-90 TO ALLOW DEPOSIT OF SAID FEES INTO THE LAW ENFORCEMENT CONTINUING EDUCATION FUND

WHEREAS, the Police Department would like to offer locker rentals to visitors of the City of Greenwood Court and Police Department;

WHEREAS, a small fee in exchange for rental of the locker storage spaces is just and fair;

WHEREAS, the Police Chief has requested said fees be deposited into the Law Enforcement Continuing Education Fund; and

WHEREAS, an amendment to the Municipal Code is necessary to do so;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, THAT:

<u>Section 1.</u> Greenwood Municipal Code (1993), as amended, Chapter 4, Article 1, Section 4-16 Chart on Fees, Permits and Licenses is hereby amended to add:

Police Building Locker Rental \$1

- <u>Section 2</u>. Greenwood Municipal Code (1993), as amended, Chapter 2, Article 9, Division I, Section 2-90 Law Enforcement Continuing Education Fund is hereby amended to add "police building locker fees under Section 4-16" to the list of fees included in subsection (b)(1).
- <u>Section 3.</u> This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
- <u>Section 4</u>. The sections, paragraphs, sentences, clauses, phrases and words of this Ordinance are separable, and if any word, phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional, invalid or unenforceable by the valid judgment or decree of a Court of competent jurisdiction, such unconstitutionality, invalidity or unenforceability shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Ordinance.
- <u>Section 5</u>. All prior ordinances or parts thereof inconsistent with any provision of this ordinance are hereby repealed. This Ordinance shall have no effect upon any other sections of the Greenwood Municipal Code (1993) or ordinances not specifically changed by this Ordinance, except as herein provided, and all other sections of the Greenwood Municipal Code (1993) not inconsistent herewith shall remain the same.
