RESOLUTION NO. 19-27

**A RESOLUTION OF THE GREENWOOD COMMON COUNCIL EXPRESSING
INTEREST IN THE PURCHASE OF CERTAIN REAL PROPERTIES FOR
STORMWATER MANAGEMENT**

WHEREAS, the Department of Stormwater Management, by and through the Board of Public Works and Safety, is interested in purchasing certain parcels of real estate for flood prevention and floodway restoration purposes and has obtained a federal grant to aid in the cost thereof;

WHEREAS, pursuant to Ind. Code § 8-1.5-5-20, all property purchased for stormwater purposes must be taken and held in the name of the unit served by the department (the City of Greenwood);

WHEREAS, pursuant to Ind. Code § 36-1-10.5, before making a purchase of real property anticipated to cost greater than Twenty-Five Thousand and No/100 Dollars (\$25,000.00), the Common Council must first pass a resolution stating its interest in making a purchase of the specified land or a structure;

NOW, THEREFORE, BE IT RESOLVED BY THE GREENWOOD COMMON COUNCIL AS FOLLOWS:

Section 1. The Common Council, pursuant to Ind. Code § 36-1-10.5, hereby expresses its interest in purchasing the following parcels of real property in Greenwood, Indiana, by the Board of Public Works and Safety for use by the Department of Stormwater Management for flood prevention and control purposes:
