There were 55 Erosion and Sediment Control permits issued, and 137 inspections. There were 4 Stormwater Management Permits and 56 inspections completed. 6 BMP Inspections. 30 hot spots cleared. This month's education was a recycling district tour. Storm line jetting was done in on Millridge Lane and Aston Parke Drive for a total of 262.74 feet of pipe cleaned.
