ORDINANCE NO. 22-22

AN ORDINANCE AMENDING THE 2022 SALARY ORDINANCE, COMMON COUNCIL ORDINANCE NO. 21-37, TO ADD POSITION OF PART-TIME RIGHT-OF-WAY LOCATOR TO THE DEPARTMENT OF STORMWATER MANAGEMENT AND TO CHANGE THE PARALEGAL-DEFERRAL COORDINATOR TITLE IN THE LEGAL DEPARTMENT

WHEREAS, the Greenwood Common Council passed Ordinance 21-37 (the “2022 Salary Ordinance”) setting 2022 salaries for all employees and stating whether each position is exempt or non-exempt;

WHEREAS, due to increased right-of-way inspection and location work in the Department of Stormwater Management, the Superintendent is requesting that a part-time right-of-way locator position be added to the department;

WHEREAS, there exist unobligated funds in the Department of Stormwater Management salary budget to compensate the part-time right-of-way locator position and no additional appropriation is currently necessary to fund the amendment;

WHEREAS, the part-time right-of-way locator position is a non-exempt position eligible for overtime under the Municipal Code;

WHEREAS, the duties and responsibilities of the Paralegal-Deferral Coordinator position in the Legal Department have changed, and the Corporation Counsel recommends that the title of the Paralegal-Deferral Coordinator position in the Legal Department be changed to Paralegal to reflect the current duties and responsibilities of the position;

WHEREAS, the full-time Paralegal position is an exempt position that is eligible for compensatory time under the Municipal Code;

WHEREAS, the change of title of the Paralegal-Deferral Coordinator position does not require a change in the compensation of the position;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, AS FOLLOWS:

Section 1. The 2022 Salary Ordinance, Common Council Ordinance No. 21-37, Section 3, is hereby amended to add a part-time position of “Right-of-Way Locator” to the Department of Stormwater Management as follows:

Section 2. The 2022 Salary Ordinance, Common Council Ordinance No. 21-37, Section 2, is hereby amended to change the title of the Paralegal- Deferral Coordinator to Paralegal in the Legal Department as follows:

Section 3. This Ordinance shall have no effect upon any other provisions of Ordinance No. 21-37 except as herein provided, and all other sections of Ordinance No. 21-37 not inconsistent herewith shall remain the same.

Section 4. The sections, paragraphs, sentences, clauses, phrases and words of this Ordinance are separable, and if any word, phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional, invalid or unenforceable by the valid judgment or decree of a Court of competent jurisdiction, such unconstitutionality, invalidity or unenforceability shall not affect any of the remaining words, phrases, clauses, sentences, paragraphs and sections of this Ordinance.

Section 5. This Ordinance shall be in full force from and after its passage, approval and publication according to law.




