

GREENWOOD COMMON COUNCIL

ORDINANCE NO. 22-39

AN ORDINANCE AMENDING THE 2022 SALARY ORDINANCE AND 2023 SALARY ORDINANCE, COMMON COUNCIL ORDINANCE NO. 21-37 AND COMMON COUNCIL ORDINANCE 22-27, TO AMEND THE POSITION OF PROBATIONARY PATROLMAN (LATERAL TRANSFER) IN THE POLICE DEPARTMENT

WHEREAS, the Greenwood Common Council passed Ordinance 21-37, “An Ordinance Fixing Salaries of Appointed Officers and Employees of the City of Greenwood, Indiana and City Utilities for the Year 2022” (the “2022 Salary Ordinance”), setting 2022 salaries for all employees and stating whether each position is exempt or non-exempt;

WHEREAS, the Greenwood Common Council passed Ordinance 22-27, “An Ordinance Fixing Salaries of Appointed Officers and Employees of the City of Greenwood, Indiana and City Utilities for the Year 2023” (the “2023 Salary Ordinance”), setting 2023 salaries for all employees and stating whether each position is exempt or non-exempt;

WHEREAS, in the 2022 and 2023 Salary Ordinances a position in the Police Department was listed as Probationary Patrolman (Lateral Transfer) and that position designation does not include non-lateral transfer Probationary Patrolman positions;

WHEREAS, the Police Department is willing to hire Probationary Patrolmen who are lateral transfers and individuals who are not, and that the title Probationary Patrolman without the lateral designation is the correct title to be included in the Salary Ordinances;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, AS FOLLOWS:

Section 1. The 2022 Salary Ordinance, Common Council Ordinance No. 21-37, Section 2, is hereby amended to list the position as Probationary Patrolman and update the salary range as follows:

Section 2. The 2023 Salary Ordinance, Common Council Ordinance No. 22-27, Section 2, is hereby amended to list the position as Probationary Patrolman and update the salary range as follows:

Section 3. This Ordinance shall have no effect upon any other provisions of Ordinance 21-37 or Ordinance 22-27 except as herein provided, and all other sections of Ordinance No. 21-37 and Ordinance No. 22-27 not inconsistent herewith shall remain the same.

Section 4. The sections, paragraphs, sentences, clauses, phrases, and words of this Ordinance are separable, and if any word, phrase, clause, sentence, paragraph, or section of this Ordinance shall be declared unconstitutional, invalid, or unenforceable by the valid judgment or decree of a Court of competent jurisdiction, such unconstitutionality, invalidity, or unenforceability shall not affect any of the remaining words, phrases, clauses, sentences, paragraphs, and sections of this Ordinance.

Section 5. This Ordinance shall be in full force and effect from and after its passage, approval, and publication according to law.




