ORDINANCE NO. 22-40

**AN ORDINANCE PROVIDING FOR AN ADDITIONAL APPROPRIATION FROM
THE AMERICAN RESCUE PLAN CORONAVIRUS LOCAL FISCAL RECOVERY
FUND TO BUDGET CLASSIFICATION 445 (\$600,000) FOR CITY CENTER
BUILDING GENERATOR, GAS LINE AND FENCE**

WHEREAS, the City of Greenwood ("City") has received its full allocation of American Rescue Plan Act of 2021 (ARP) funds;

WHEREAS, the U.S. Department of the Treasury Final Rule to implement the Coronavirus Local Fiscal Recovery Fund ("Final Rule") allows the use of ARP Coronavirus Local Fiscal Recovery Fund ("Fund") money to be used to provide government services to the extent of reduction in revenue, which reduction is presumed to have been due to the COVID-19 public health emergency;

WHEREAS, the Rule further provides that government services for which Fund money may be spent includes the provision of equipment;

WHEREAS, the Mayor recommends investment in utility improvements to the City Center Building to reduce interruption in the provision of services to constituents caused by power outages;

WHEREAS, power outages at the City Center Building may compromise the safety of the people and assets of the City of Greenwood;

WHEREAS, the City Controller requests an additional appropriation from the Fund in the amount of Six Hundred Thousand and no/100 Dollars (\$600,000.00) to budget classification Capital Outlay – 445 Machinery and Equipment to purchase and install a Stateline 450 Kilowatt Generator, natural gas line and meter, and fencing around the generator, at the City Center Building;

WHEREAS, the Controller has determined that the Fund has a sufficient balance available to fund the purchase;

WHEREAS, the Common Council has determined that it is necessary and appropriate to make the requested additional appropriation, and shall hold a public hearing regarding the appropriation in accordance with law,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, THAT:


Section 1. For the expenses of the City of Greenwood, the following additional sum of money are hereby appropriated and ordered set apart out of the fund herein named and for the purposes herein specified, subject to the laws governing the same:

<u>ARP CORONAVIRUS LOCAL FISCAL RECOVERY FUND (FUND 176)</u>	<u>Amount</u>
Machinery and Equipment - 445	\$600,000.00

Said sum is to be used for expenditures of the type and kind permitted by law.

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.




