## **ORDINANCE NO. 23-09**

## AN ORDINANCE PROVIDING FOR AN ADDITIONAL APPROPRIATION FROM THE AMERICAN RESCUE PLAN CORONAVIRUS LOCAL FISCAL RECOVERY FUND TO BUDGET CLASSIFICATION 445 (\$425,943) FOR FIRE APPARATUS AND SECURITY CAMERAS

WHEREAS, the City of Greenwood ("City") has received its full allocation of American Rescue Plan Act of 2021 (ARP) funds;

WHEREAS, the U.S. Department of the Treasury Final Rule to implement the Coronavirus Local Fiscal Recovery Fund ("Final Rule") allows the use of ARP Coronavirus Local Fiscal Recovery Fund ("Fund") money to be used to provide government services to the extent of reduction in revenue, which reduction is presumed to have been due to the COVID-19 public health emergency;

WHEREAS, the Rule further provides that government services for which Fund money may be spent includes the provision of equipment;

WHEREAS, the Mayor recommends investment in security cameras at the Fieldhouse Parking Garage, Greenwood Indy South Airport, and Police Training Center to promote security for the citizens of the City;

WHEREAS, the presence of security cameras at the Fieldhouse Parking Garage, Greenwood Indy South Airport, and Police Training Center will promote the safety of the people and assets of the City of Greenwood;

WHEREAS, the City Controller requests an additional appropriation from the Fund in the amount of One Hundred Eleven Thousand One Hundred Twenty-Nine and no/100 Dollars (\$111,129.00) to budget classification Capital Outlay – 445 Machinery and Equipment to purchase and install Avigilon Security Cameras at the Fieldhouse Parking Garage, Greenwood Indy South Airport, and Police Training Center;

WHEREAS, the Mayor further recommends investment in fire apparatus and equipment for the Greenwood Fire Department;

WHEREAS, the Greenwood Fire Department needs reliable fire apparatus and equipment to safely and effectively provide fire protection services to the people and property of the City of Greenwood;

WHEREAS, the City Controller requests an additional appropriation from the Fund in the amount of Three Hundred Fourteen Thousand Eight Hundred Fourteen and no/100 Dollars (\$314,814.00) to budget classification Capital Outlay – 445 Machinery and Equipment to fund a surcharge imposed by the vendor due to supply chain complications caused by the Coronavirus pandemic on one (1) Seagrave model TT05CT Marauder 100 ft 500 lb Tractor Drawn Aerial and one (1) Seagrave model TB40CT Marauder Pumper;

WHEREAS, the Controller has determined that the Fund has a sufficient balance available to fund the purchase;

WHEREAS, the Common Council has determined that it is necessary and appropriate to make the requested additional appropriation, and shall hold a public hearing regarding the appropriation in accordance with law,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, THAT:

<u>Section 1</u>. For the expenses of the City of Greenwood, the following additional sum of money is hereby appropriated and ordered set apart out of the fund herein named and for the purposes herein specified, subject to the laws governing the same:
