Appearing before the council: Honorable Judge Lewis Gregory, Greenwood City Court. I am requesting that we transfer this money from our personnel account (100 numbered accounts) in order to access to these. We had a position that was vacant for a period of several months and the salary for that position accumulated. In the meantime, various factors had caused the need for additional assistance in the form of a second person working as a public defender. Judge Gregory does not anticipate this is going to be a permanent long time requirement. It will help with current caseload requirements. Judge Gregory deemed this necessary, and stated that no new money is being requested, but that it is being moved from one category to another. This will be used for the salary of an second attorney that will be used as a public defender.

Mr. Foster: Inquired as to whether this was because of caseload, or a combination of factors.

Judge Gregory stated that the increased caseload, and coupled with the amount of people without job or money that are entering the criminal justice system and cannot afford an attorney result in those combinations

Mr. Taggart , Director Parks and Recreation appeared before the council and spoke: The City has seen an exponential growth in the past four or five years. We see in the coming years the operations to increase in the trending pace that it has in the past. We have the impending fieldhouse, and it is possible other large capital projects. The operations need to be shared as far as overseeing some of these operations of these facilities as far as management is concerned as well. We are looking for someone to fill a position that will help with that as well help within the department. Mr. Campbell: Any questions for Mr. Taggart? Mr. Dine: What are the qualifications required for this position? Mr. Taggart: Of the qualifications that are required to have this position is somebody with some administrative background, some financial background, some experience with grant writing. Operational experience, management experience as well. Mr. Dine: Is there any one currently on the staff now that fits that need? Mr. Taggart: We certainly keep track of people that are on staff and we will assess their skill sets as well. In this instance, we will actually look outside for using other forums such as IPRA (Indiana Parks and Recreation Associations). Mr. Bates: I talked to Rob about this being probably outside for this position, and that it had also been post on the City website. With the last communications, I had with Rob I think we have just answered here in part. Mr. Taggart: We certainly encourage and to maintain the integrity of the hiring event, we would like to and will go further with that, and will consider the search pool we have, and will certainly advertise as well. Mr. Bates: To advertise, for out, do we have a time frame? It that a period of 10 days or 20 days? Mr. Taggart: I would like to see someone get onboard between now and October.

Mr. Bates: Will you, at some point in time, be asking for an additional appropriation? Mr. Taggart: Currently we have money in the appropriation to fund this. Probably later in the year, we will have a shortfall of about \$25,000.
