RESOLUTION NO. 23-13

**A RESOLUTION OF THE GREENWOOD COMMON COUNCIL AUTHORIZING
CONTINUED PARTICIPATION IN THE INTERLOCAL ASSOCIATION FOR AN
ADDITIONAL FIVE YEAR PERIOD**

WHEREAS, the City of Greenwood's participation in the agreement for joint and cooperative action, as described in the Joint Resolution and Articles of Agreement of the Interlocal Cooperation Act of Indiana, has proven advantageous to the public interest;

WHEREAS, the City of Greenwood has willingly participated in the Interlocal Association for several years and desires to continue such participation;

WHEREAS, Section 2 of the Joint Resolution and Articles of Agreement state that the Agreement shall be renewed for five-year periods; and

WHEREAS, it has been determined that it is desirable, advantageous, and in the public interest to renew the existing agreement for joint and cooperative action for a five-year period,

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, THAT:

Section 1. The Common Council joins with other local units of government in the continuation of the Interlocal Association under the terms described in the Joint Resolution and Articles of Agreement previously authorized, the terms of which are incorporated herein by reference, and said Agreement is hereby renewed for an additional five (5) year period beginning August 27, 2023 and expiring on August 27, 2028.

Section 2. The duly elected or appointed officials whose signatures appear below execute and affix their signatures as indicated to this Resolution and Agreement and authorize the Mayor of the City of Greenwood to execute any reasonable and necessary documents for the City of Greenwood to participate in the said Interlocal Association.

Section 3. The sections, paragraphs, sentences, clauses, phrases and words of this Resolution are separable, and if any word, phrase, clause, sentence, paragraph or section of this Resolution shall be declared unconstitutional, invalid or unenforceable by the valid judgment or decree of a court of competent jurisdiction, such unconstitutionality, invalidity or unenforceability shall not affect any of the remaining words, phrases, clauses, sentences, paragraphs and sections of this Resolution.

Section 4. This Resolution shall be in full force and effect from and after its passage and approval by the Mayor of the City of Greenwood.
