**A RESOLUTION ESTABLISHING HOLIDAYS FOR EMPLOYEES OF THE
CITY OF GREENWOOD FOR THE YEAR 2024**

WHEREAS, pursuant to Greenwood Municipal Code (1993), as amended, § 2-68(b), the Mayor and Common Council of the City of Greenwood, Indiana, are to establish holidays for the year 2024 by resolution on or before the last regular meeting of the Common Council in the year 2023; and

WHEREAS, Greenwood Municipal Code § 2-68 requires the Common Council to state by resolution each year which Actual Holidays the City will celebrate and the days upon which those Actual Holidays will be recognized.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, THAT:
