ORDINANCE NO. 24-46

AN ORDINANCE TRANSFERRING FUNDS WITHIN THE GENERAL FUND FOR THE LEGAL DEPARTMENT FROM BUDGET CATEGORY 439000 (\$4,000.00) TO BUDGET CATEGORY 421000 – OFFICE SUPPLIES AND 429000 – OTHER SUPPLIES

WHEREAS, funds may be transferred from one major budget category to another major budget category within a fund by ordinance of the fiscal body at a public meeting without advertising a public hearing if no additional appropriation is required;

WHEREAS, it is recommended that some of the money in the major budget classification of the Legal Department, Other Services and Charges 439000 – Other Services and Charges would be better spent in Legal Department major budget classification Supplies 421000 – Office Supplies and 429000 – Other Supplies, to cover costs of yearend office supplies purchase for the remainder of the year; and

WHEREAS, an ordinance is needed to transfer money from one major budget classification to another major budget classification within the Legal Department,

WHEREAS, no additional appropriation is necessary to accommodate this change.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, THAT:

Section 1: For the expenses of the City of Greenwood, and its institutions for the fiscal year ending December 31, 2024, the City of Greenwood hereby determines the transfer of the following sum of money to be necessary and the following sum is hereby transferred and ordered set apart out of the fund herein named subject to the laws governing the same:
