**A RESOLUTION OF THE GREENWOOD COMMON COUNCIL EXPRESSING  
INTEREST IN THE PURCHASE OF VACANT LAND ON THE NORTHWEST  
QUADRANT OF INTERSTATE 69 AND FAIRVIEW ROAD**

WHEREAS, the City of Greenwood is interested in purchasing approximately 580 acres of vacant land on the northwest quadrant of Interstate 69 and Fairview Road for Greenwood Sanitation Utility purposes;

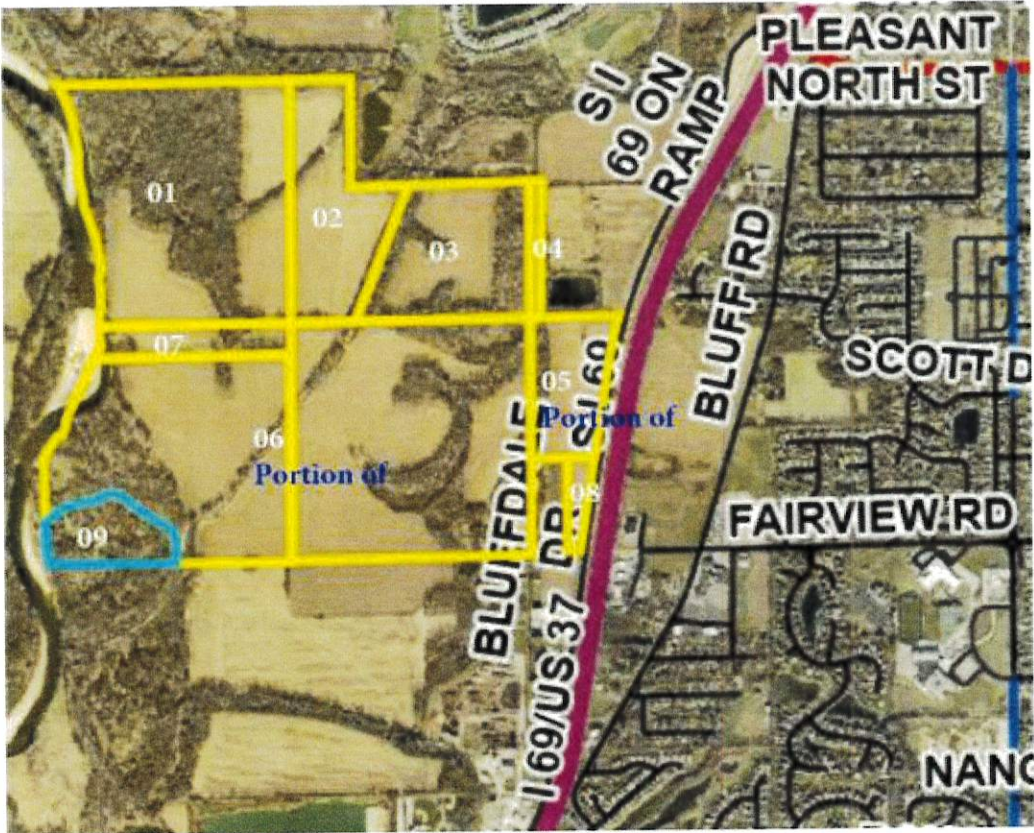
WHEREAS, pursuant to Ind. Code § 36-1-10.5, before making a purchase of real property anticipated to cost greater than Twenty-Five Thousand and No/100 Dollars (\$25,000.00), the Common Council must first pass a resolution stating its interest in making a purchase of the specified land;

NOW, THEREFORE, BE IT RESOLVED BY THE GREENWOOD COMMON COUNCIL AS FOLLOWS:

Section 1. The Common Council, pursuant to Ind. Code § 36-1-10.5, hereby expresses its interest in purchasing the following vacant land in White River Township, Johnson County, Indiana, totaling approximately 580 acres for Greenwood Sanitation Utility purposes, specified and shown as follows:

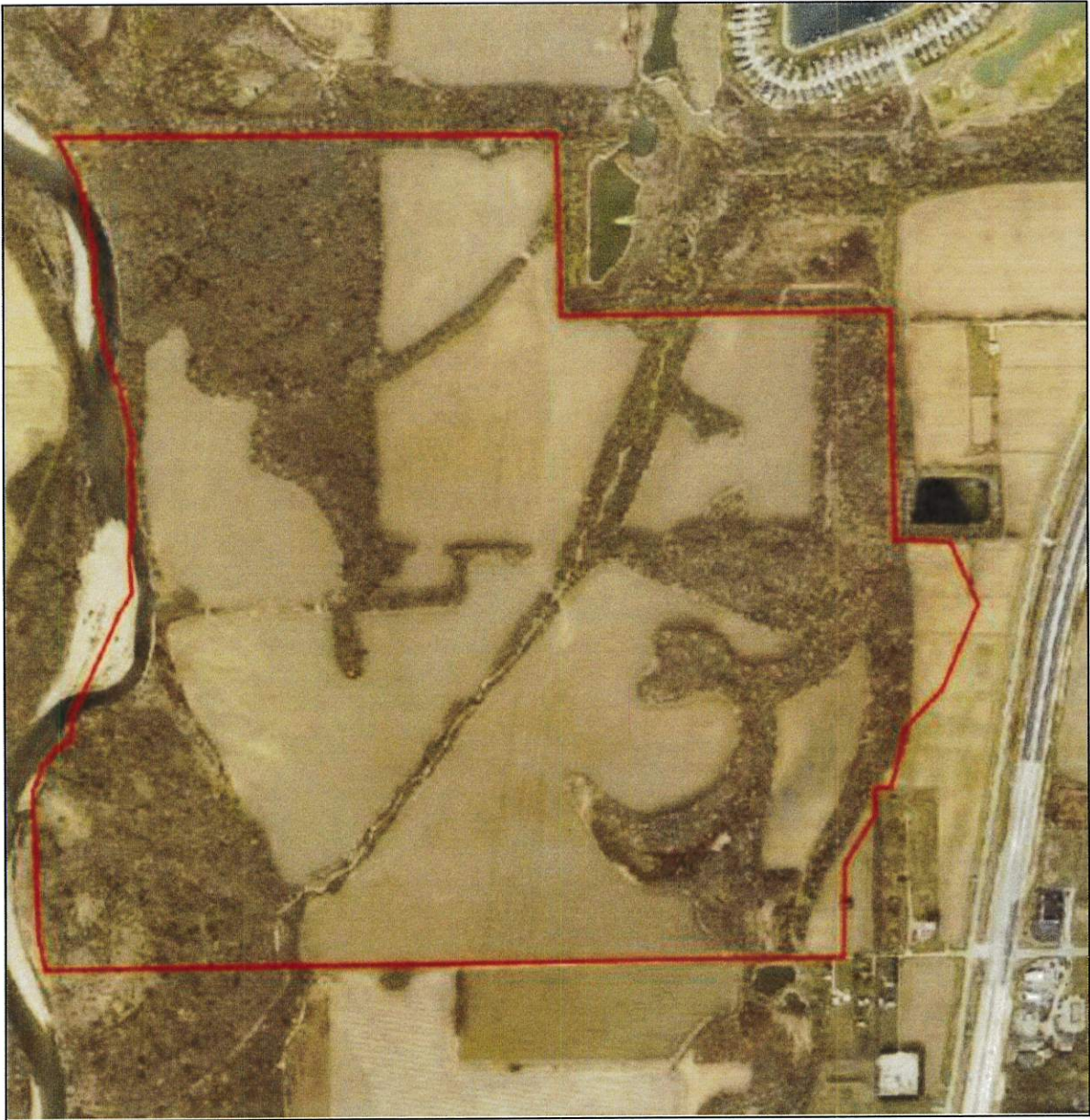
