**A RESOLUTION OF THE GREENWOOD COMMON COUNCIL ENCOURAGING  
THE MAYOR TO RENAME A PORTION OF STOP 18 ROAD EVAN SPRINGER  
BLVD.**

WHEREAS, Evan Springer began working for the City of Greenwood in 1975 and became the Director of Parks and Recreation in 1978;

WHEREAS, Mr. Springer served the City of Greenwood with dedication and honor for thirty-eight (38) years;

WHEREAS, Mr. Springer oversaw the expansion of the City of Greenwood's park, trail and recreation system;

WHEREAS, Mr. Springer was a long term member of the Indiana Park & Recreation Association and the National Park & Recreation Association;

WHEREAS, Mr. Springer was instrumental in the purchase and development of Freedom Park and the City's quest for a true aquatic facility;

WHEREAS, the Common Council would like to recognize Mr. Springer's years of dedication and service and the impact he has had on the community;

WHEREAS, Indiana Code provides that the executive of the City is charged with naming streets; and

WHEREAS, the Common Council believes it would be proper and fitting to rename the portion of Stop 18 Road that enters into Freedom Park in honor of Mr. Springer.

NOW, THEREFORE, BE IT RESOLVED BY THE GREENWOOD COMMON COUNCIL AS FOLLOWS:

Section 1. The Common Council hereby encourages the Mayor to rename the portion of Stop 18 Road that enters into Freedom Park "Evan Springer Blvd." in honor of Mr. Springer's dedication and service.

Section 2. This Resolution shall be in full force and effect after its passage and approval by the Mayor of the City of Greenwood.
