

**GREENWOOD COMMON COUNCIL**

**ORDINANCE NO. 19-23**

**AN ORDINANCE TRANSFERRING FUNDS WITHIN THE GENERAL FUND FOR  
THE CITY COURT FROM BUDGET CATEGORY 111 (\$11,675) TO BUDGET  
CATEGORY 331 FOR PUBLIC DEFENDER**

WHEREAS, funds may be transferred from one major budget category to another major budget category within a fund by ordinance of the fiscal body at a public meeting without advertising a public hearing if no additional appropriations are required;

WHEREAS, due to an increase in the caseload of the City Court, the City Court Judge recommends hiring a second public defender;

WHEREAS, compensation of the public defender requires transferring funds from City Court General Fund Budget Category Personal Services 111 -Salaries to Budget Category Other Services and Charges 331 - Professional Services in the amount of Eleven Thousand Six hundred Seventy-Five and No/100 Dollars (\$11,675.00);

WHEREAS, no additional appropriation is necessary to accommodate these changes.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, THAT:

Section 1: For the expenses of the City of Greenwood, and its institutions for the fiscal year ending December 31, 2019, the City of Greenwood hereby determines the transfer of the following sums of money to be necessary and the following sums are hereby transferred and ordered set apart out of the fund herein named subject to the laws governing the same:

Section 2. It has been shown that a certain existing Fund now has unobligated balances which will not be used or encumbered, it is further ordained that the following Fund be reduced by the following amounts and said amounts be transferred subject to the laws governing the same:

Section 3. This transfer does not necessitate expenditure of more money than was set out in the published budget for the year 2019, there is no necessity of advertising said transfer, and it may be done in any regular public meeting without notice, and without approval of the Department of Local Government Finance.


Section 4. This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
