## AN ORDINANCE VACATING PLATTED DETENTION EASEMENT IN THE REPLAT BLOCK B GREENBROOKE PARKE

WHEREAS, a Petition has been filed with the Greenwood City Clerk on behalf of County Line Properties, LLC ("County Line") to vacate the approximately 1.54 acre platted detention easement in the Replat Block B Greenbrooke Parke, in accordance with Ind. Code §§ 36-7-3-12 and 16;

WHEREAS, County Line owns Block B of Greenbrooke Parke and has worked with Smith/Packett (AL Investors LLC) to develop the subject property as an upscale senior living community;

WHEREAS the proposed site development plan for the senior living community relocates the detention pond from the northwest portion of the parcel to the southern portion, and vacation of the platted detention easement is necessary to accommodate the relocation of the detention pond and the development of the property;

WHEREAS, the Greenwood Advisory Plan Commission and the Greenwood Board of Public Works and Safety have favorably recommended to the Greenwood Common Council the approval of said Petition;

WHEREAS, the vacation of the platted detention easement will not hinder the growth or orderly development of the property on which the easement is located, will not make access to the property by means of a public way difficult or inconvenient, will not hinder the public's access to a church, school or other public building or place, will not hinder the use of a public way by the neighborhood in which the subject property is located or to which it is contiguous, nor will it adversely affect the health, safety, or welfare of the general public or the delivery of services to the public;

WHEREAS, said Petition was scheduled for a hearing before the Greenwood Common Council on Monday, June 19, 2023 at 7:00 p.m. and due notice of said hearing having been made in accordance with Indiana Code §§ 36-7-3-12, 36-7-3-16 and 5-3-1, the same is now properly before the Greenwood Common Council for action.


NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, AS FOLLOWS:

<u>Section 1.</u> The approximately 1.54 acre platted detention easement on the Final Plat Replat Block B Greenbrooke Parke, recorded in Plat Cabinet "E 268", Page Slide A & B, on July 21, 2017 as Instrument Number <u>2017-016319</u>, in the Office of the Johnson County Recorder, more particularly described and shown as follows:

Section 4. This ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
