

GREENWOOD COMMON COUNCIL

ORDINANCE NO. 24-16

AN ORDINANCE PROVIDING FOR ADDITIONAL APPROPRIATIONS FROM THE FIRE FUND TO BUDGET CLASSIFICATIONS 422 (\$135,828), 429 (\$39,654) AND 431 (\$31,080) FOR NEW HIRE SUPPLIES, EQUIPMENT, AND PHYSICALS, AND TO BUDGET CLASSIFICATION 439 (\$13,342) FOR TORNADO SIREN SYSTEM UPGRADES

WHEREAS, the Greenwood Fire Department has initiated a process to hire twenty-one (21) firefighters this year and the large hiring process was not anticipated at the time the 2024 budget was adopted;

WHEREAS, the unanticipated 2024 budget costs associated with the large hiring process include turnout gear and self-contained breathing apparatus (SCBA) masks and regulators at a cost of One Hundred Thirty-Five Thousand Eight Hundred Twenty-Eight and no/100 Dollars (\$135,828.00); recruit/on duty uniforms at a cost of Thirty-Nine Thousand Six Hundred Fifty-Four and no/100 Dollars (\$39,654.00), collectively, “supplies and equipment”; and Public Employment Retirement Fund (PERF) physicals at a cost of Thirty-One Thousand and 80/100 Dollars (\$31,080.00);

WHEREAS, the Greenwood Fire Chief recommends new software and other upgrades to improve the tornado siren warning system which were not anticipated at the time the 2024 budget was adopted, and the upgrades are estimated to cost Thirteen Thousand Three Hundred Forty-Two and no/100 Dollars (\$13,342.00);

WHEREAS, the City Controller has determined that the Fire Fund has a sufficient balance to fund the purchase of the new hire supplies and equipment, the fees for the PERF physicals, and the tornado siren warning system upgrades;

WHEREAS, the City Controller requests additional appropriations from the Fire Fund in the following amounts: One Hundred Thirty-Eight Thousand Eight Hundred Twenty-Eight and no/100 Dollars (\$135,828.00) to Budget Classification Supplies – 422 Operating Supplies; Thirty-Nine Thousand Six Hundred Fifty-Four and no/100 Dollars (\$39,654.00) to Budget Classification Supplies – 429 Other Supplies; Thirty-One Thousand and 80/100 Dollars (\$31,080.00) to Budget Classification Other Services and Charges – 431 Professional Services; and Thirteen Thousand Three Hundred Forty-Two and no/100 Dollars (\$13,342.00) to Budget Classification Other Services and Charges – 439 Other Services and Charges, to allow the Fire Department to hire twenty-one (21) firefighters and perform upgrades to the tornado siren warning system;

WHEREAS, the Common Council has determined that it is necessary and appropriate to make the requested additional appropriations and shall hold a public hearing in accordance with law,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, THAT:

Section 1. For the expenses of the City of Greenwood, the following additional sums of money are hereby appropriated and ordered set apart out of the fund herein named and for the purposes herein specified subject to the laws governing the same:

FIRE FUND (FUND 294202)

Supplies – 422 Operating Supplies	\$135,828.00
Supplies – 429 Other Supplies	\$ 39,654.00
Other Services and Charges – 431 Professional Services	\$ 31,080.00
Other Services and Charges – 439 Other Services and Charges	\$ 13,342.00

Said sums are to be used for expenditures of the type and kind permitted by law.

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
