RESOLUTION NO. 24-11

A RESOLUTION OF THE GREENWOOD COMMON COUNCIL TO ADOPT AND APPROVE A COMPREHENSIVE PLAN FOR THE CITY OF GREENWOOD IN ACCORDANCE WITH THE PROVISIONS OF IND. CODE § 36-7-4-500 et seq., AS AMENDED

WHEREAS, the Greenwood Advisory Plan Commission (hereinafter "Commission") has prepared a comprehensive plan entitled, "City of Greenwood Comprehensive Plan" (hereinafter "Comprehensive Plan") in accordance with Ind. Code § 36-7-4-500 *et seq.*, as amended, to provide policies, goals and objectives for the future development of the City of Greenwood;

WHEREAS, the Commission has held at least one (1) public hearing to consider and discuss said Comprehensive Plan for the City of Greenwood;

WHEREAS, the Commission has approved, certified and presented to the Greenwood Common Council a Comprehensive Plan entitled "City of Greenwood Comprehensive Plan";

WHEREAS, the Greenwood Common Council has reviewed the certified Comprehensive Plan and determines it is in the best interest of the City of Greenwood to adopt it,

NOW, THEREFORE, BE IT RESOLVED BY THE GREENWOOD COMMON COUNCIL AS FOLLOWS:

Section 1. The Greenwood Common Council finds that the Comprehensive Plan entitled "City of Greenwood Comprehensive Plan" will promote the public health, safety, morals, convenience, order and general welfare and promote efficiency and economy in the process of development of the City of Greenwood.

Section 2. The Greenwood Common Council hereby adopts and approves the Comprehensive Plan entitled "City of Greenwood Comprehensive Plan", attached hereto and made a part hereof, which plan includes all documents incorporated into the plan by reference.

Section 3. The "City of Greenwood, IN Comprehensive Plan 2007-2027", and the amendments thereto, are hereby repealed and replaced by the "City of Greenwood Comprehensive Plan". The repeal of the "City of Greenwood, IN Comprehensive Plan 2007-2027" and the amendments thereto shall not affect any proposal properly filed with the City of Greenwood prior to the effective date of the "City of Greenwood Comprehensive Plan", as such proposals shall continue under the "City of Greenwood, IN Comprehensive Plan 2007-2027" and its amendments as if the "City of Greenwood Comprehensive Plan" had not been adopted and approved.

Section 4. The Greenwood Common Council states that two (2) copies of the "City of Greenwood Comprehensive Plan" are on file and shall be kept on file in the office of the Clerk of the City of Greenwood, Indiana for public inspection.

Section 5. The City of Greenwood Clerk is hereby directed to file in the Office of the Johnson County Recorder one (1) copy of the "City of Greenwood Comprehensive Plan".

Section 6. This Resolution shall be in full force and effect from and after its adoption.


