Encroachment Request

APPLICATION

A completed application form along with all required attachments, as outlined below, are to be submitted by the date shown under the "Application Submittal Deadline" column on the attached BPWS Meeting Schedule. After receipt of all items, staff will review the application to determine whether the application is complete. If the application is not complete, it will be returned to the applicant with the identified deficiencies. Applications submitted after the posted "Application Submittal Deadline" date for a BPWS meeting will be placed on the application cycle for the next regularly scheduled BPWS meeting.

- D Completed Application Form.** You must include the nature of your request, who will represent the request at the BPWS meeting along with the representatives appropriate contact information such as email address and telephone number.

- D Certificate of Mailing.** It is the applicant's responsibility to notify each utility company shown on the list provided by the City in the attached application packet. The letter to each utility must state the applicant's intent to encroach into the easement (state type of easement; drainage, utility, sanitary sewer, etc.) and the encroachment being requested (fence, pool, etc.). The letter must also state that the utility company may attend the City of Greenwood Board of Public Works and Safety meeting on (insert date of meeting) to present comments, for or against the encroachment request. A drawing must also be submitted with the letter to each utility company.

- D Letter from Homeowner's Association.** You must obtain a signed letter from your Homeowner's Association, if applicable, stating its position regarding the encroachment request.

- D Drawing.** An accurate and scaled drawing, showing how the easement area will be encroached upon.

- D Submittal.** The application form, a completed and executed certificate of mailing form by the post office, the original signed letter from your Homeowner's Association, if applicable, and an accurate drawing must be submitted to the engineering division at:

PLEASE NOTE: The Engineering Division will recommend against approval of the installation of any encroachment within any rear yard easement. However, the final decision is up to the Board of Public Works and Safety. The Engineering Division will consider, on a case by case basis, the installation of any encroachment within any side yard easement.
