A RESOLUTION OF THE GREENWOOD COMMON COUNCIL EXPRESSING INTEREST IN THE PURCHASE OF CERTAIN REAL PROPERTY ON RAY CROWE WAY

WHEREAS, the City of Greenwood is interested in purchasing a portion of land from a parcel of real estate located at 1360 E. Ray Crowe Way for potential expansion of public parking for the Sports Park;

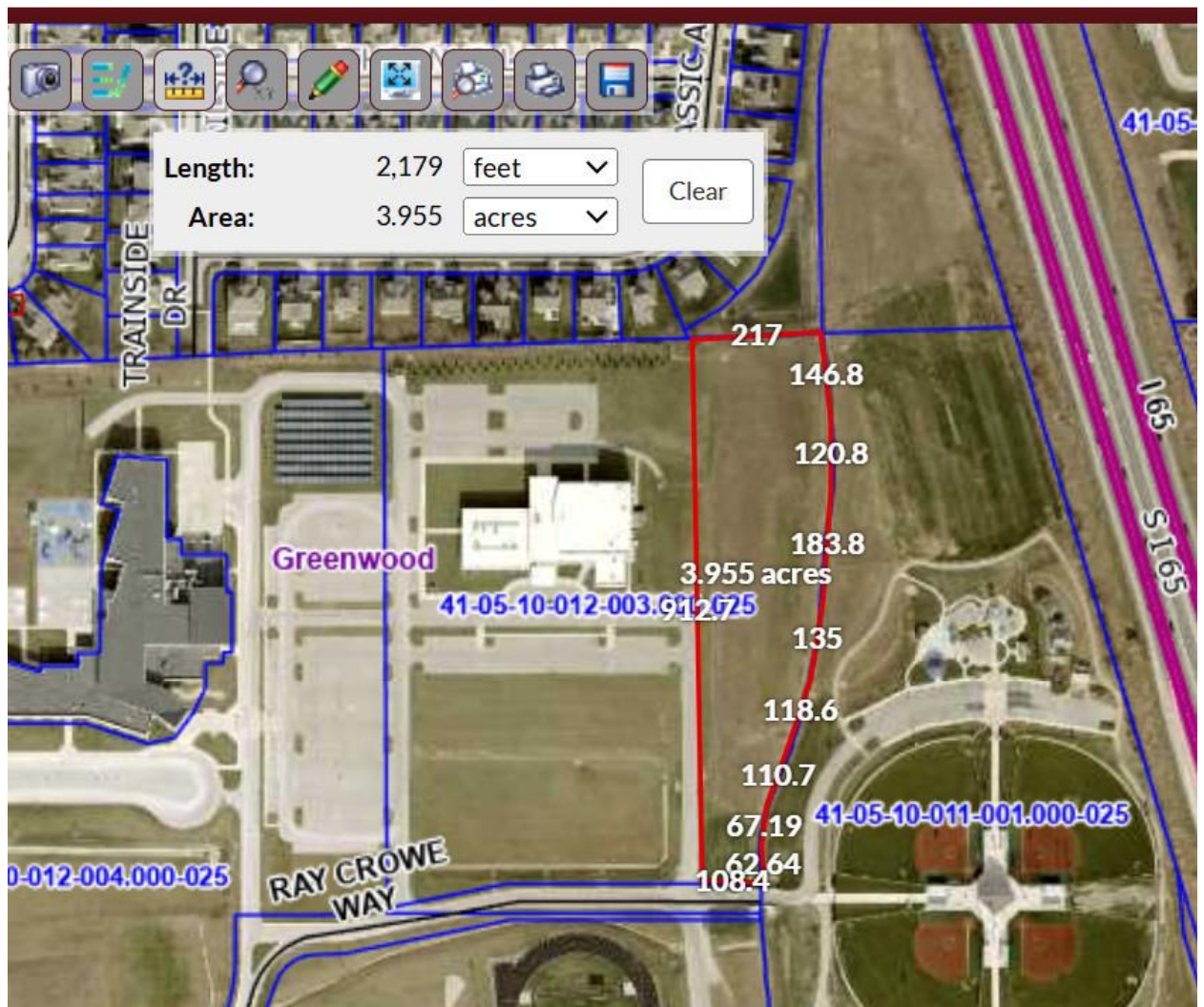
WHEREAS, pursuant to Ind. Code § 36-1-10.5, before making a purchase of real property anticipated to cost greater than Twenty-Five Thousand and No/100 Dollars (\$25,000.00), the Common Council must first pass a resolution stating its interest in making a purchase of the specified land or a structure;

NOW, THEREFORE, BE IT RESOLVED BY THE GREENWOOD COMMON COUNCIL AS FOLLOWS:

Section 1. The Common Council, pursuant to Ind. Code § 36-1-10.5, hereby expresses its interest in purchasing the following real property in Greenwood, Indiana, for public parking purposes, described and shown in red as follows:
