

**GREENWOOD COMMON COUNCIL**

**ORDINANCE NO. 26-16**

**AN ORDINANCE AMENDING THE 2026 SALARY ORDINANCE, COMMON COUNCIL ORDINANCE NO. 25-20, TO REMOVE THE POSITION OF STAFF LIEUTENANT OF SUPPORT SERVICES AND ADD THE POSITION OF SUPPORT SERVICES COORDINATOR IN THE FIRE DEPARTMENT**

WHEREAS, the Greenwood Common Council passed Ordinance 25-20, "An Ordinance Fixing Salaries of Appointed Officers and Employees of the City of Greenwood, Indiana and City Utilities for the Year 2026" (the "2026 Salary Ordinance"), setting 2026 salaries for all employees and stating whether each position is exempt or non-exempt;

WHEREAS, there is currently one (1) full-time Staff Lieutenant of Support Services position in the Fire Department, and the Fire Chief requests that this position be removed as the person who occupied that position will be or has now retired;

WHEREAS, the Fire Chief requests to add one (1) civilian position of Support Services Coordinator in the Fire Department;

WHEREAS, the Support Services Coordinator in the Fire Department will maintain similar duties as the Staff Lieutenant of Support Services position, but in a civilian capacity;

WHEREAS, the 2026 Salary Ordinance requires an amendment to remove the Staff Lieutenant of Support Services position in the Fire Department and to add one (1) position of Support Services Coordinator;

WHEREAS, no additional appropriation by the Common Council is necessary to fund these amendments;

WHEREAS, the Support Services Coordinator position is an exempt position and not eligible for overtime compensation under the Municipal Code.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, AS FOLLOWS:

Section 1. The 2026 Salary Ordinance, Common Council Ordinance No. 25-20, Section 2, is hereby amended to add one (1) position of Support Services Coordinator as follows:

Section 2. The 2026 Salary Ordinance, Common Council Ordinance No. 25-20, Section 2, is hereby amended to delete the following:

Section 3. This Ordinance shall have no effect upon any other provisions of Ordinance No. 25-20 except as herein provided, and all other sections of Ordinance No. 25-20 not inconsistent herewith shall remain the same.

Section 4. The sections, paragraphs, sentences, clauses, phrases and words of this Ordinance are separable, and if any word, phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional, invalid or unenforceable by the valid judgment or decree of a Court of competent jurisdiction, such unconstitutionality, invalidity or unenforceability

shall not affect any of the remaining words, phrases, clauses, sentences, paragraphs and sections of this Ordinance.

Section 5. This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.


